DAYBREAK contains polyacrylamide polymer that enhances tank mix viscosity to reduce spray fines for minimizing off target spray drift.

Spray deposition is enhanced by DAYBREAK to provide more uniform spray coverage.

The antifoam ingredient in DAYBREAK suppresses excessive foaming during agitation.

Use Rates: Use DAYBREAK at 9 to 17 pounds per 100 gallons of water to deliver 1% to 2% w/w of ammonium sulfate.

Always monitor spray patterns for use rates greater than 17 pounds per 100 gallons.

Mixing Instructions

Unless otherwise instructed by accompanying crop protection label, follow these mixing instructions:

- 1. Fill spray tank one half full of water and begin agitation.
